

N Chauncey Ave / Columbia St

N Chauncey Ave between Columbia St and North St will close at 8 am on 09/16/2016 and remain closed until 11 pm on 09/17/2016.

Columbia St between N Chauncey Ave and Northwestern Ave will close at 7 am on 09/17/2016 and remain closed until 11 pm on 09/17/2016.

Sign package for street closure:

N Chauncey Ave at North St – 4 large water filled barricades and “Road Closed” sign

N Chauncey Ave alley behind Library – 2 orange striped barricades with rubber bases

N Chauncey Ave at Columbia St – 5 large water filled barricades and “Road Closed” sign

Will be used to just block N Chauncey Ave on 09/16/2016, but moved to cross the intersection at a diagonal on morning of 09/17/2016 to block both N Chauncey Ave and Columbia St.

Columbia St at Northwestern Ave – 4 large water filled barricades and “Road Closed” sign

Columbia St at Salisbury St – 2 orange striped barricades with rubber bases and “Road Closed Ahead” sign.
