A deposit of \$10/barricade will be required, to be left at the Street Department Office. Replacement costs will be charged for loss or damage to the barricade. Easy and immediate access for emergency vehicles is to be maintained at all time. No non-movable or permanent structures are to be erected in the roadway.

This form gives permission ***only for the closing of a street or an alley***. Any function taking place in the street or alley is subject to the same restrictions as any other gathering, including the enforcement of the Noise Ordinance. Compliance with the law is the responsibility of the above group. Someone "in charge" should be present at all times.

**2 large barricades** – blocking South St from State St

**2 large barricades** – blocking South St on west side of N Chauncey Ave

**4 small barricades** – on W Columbia St at entrance to West Lafayette Library Parking Garage

**2 small barricades** – in alley between South St / W Columbia St east of Northwestern Ave

**2 small barricades** – in alley beside Pot Belly Sandwiches on west side of Northwestern Ave

**2 small barricades** – in alley between Frontier Building and West Lafayette Library on east side of Northwestern Ave

**4 small barricades** – on South St at parking lot of Chase Bank

**Electronic Sign Board** – on Northwestern Ave between Fowler / Wiggins advising Northwestern Ave closed ahead

**“Road Closed Ahead”** – on Northwestern Ave near WLF D Station #1

**“Road Closed”** – sign at barricades on Northwestern Ave at North St

**“Road Closed Ahead”** – on W Columbia St just west of N Salisbury St

**“Road Closed”** – sign at barricades on W Columbia St at N Chauncey Ave

**“No Right Turn”** – on State St just east of intersection with South St
