

ORDINANCE NO. 31-12

**AN ORDINANCE TO AMEND WEST LAFAYETTE CITY CODE CHAPTER 21
CONCERNING THE DESIGNATION OF COUNCIL DISTRICTS**

WHEREAS, Indiana Code § 36-4-6-4 requires cities of the third class to designate council districts during the second year after a year in which a federal decennial census is conducted, and;

WHEREAS, a federal decennial census was conducted in 2010, mandating that district divisions be ordained prior to December 31, 2012, and;

WHEREAS, the current council district divisions no longer satisfy the requirements set forth in applicable state and federal law.

THEREFORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE that:

Section 1. Section 21.12 of the West Lafayette City Code be amended as follows:

- (a) District One shall be composed of Block 1006 of Census Tract 105, Blocks 1000, 1001, 1002, 1009, 1015, 1016, 1017, 1018, 1021, 1022, 1023, 1024, 1025, 1026, 1027, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, and 2014 of Census Tract 55, Blocks 1001 and 1008 of Census Tract 106, and Blocks 1014, 1015, 1028, 1029, 1030, 1031, 1032, 1033, 1034, 1035, 1036, 1038, 1039, 1040, 1041, 1042, 1043, 1044, 2015, 2016, 2017, 2018, 2019, 2020, and 2021 of Census Tract 54.
- (b) District Two shall be composed of Blocks 1000, 1001, 1002, 1003, 1004, 1005, 1006, 1007, 1010, 1011, 1012, 1016, 1021, 2000, 2001, 2002, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 3000, 3001, 3002, 3003, 3004, 3005, 3006, 3007, 3008, 3009, 3010, 3011, 3013, 3014, 3015, 3016, 3017, 3018, 3019, 3020, 3021, 3022, and 3025 of Census Tract 54, Blocks 1015, 1019, and 1020 of Census Tract 103, and Blocks 1010, 1011, 1023, 1024, 1025, 1026, 1027, 2005, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022, 2023, and 2024 of Census Tract 53.
- (c) District Three shall be composed of Blocks 1001, 1003, 1004, 1005, 1006, 1007, 1008, 1009, 1012, 1013, 1014, 1015, 1016, 1017, 1018, 1019, 1020, 1022, 1028, 1030, 1032, 2000, 2001, 2002, 2003, 2006, 2007, 2008, 2009, and 2010 of Census Tract 53, Blocks 1000, 1001, 1002, 1003, 1004, 1005, 1006, 1007, 1008, 1009, 1010, 1011, 1012, 1013, 1014, 3000, 3001, 3002, 3003, 3004, 3005, 3006, 3007, 3008, 3009, 3010, 3011, 3012, 3013, 3014, 3015, 3016, 3017, 3018, 3019, 3020, 3021, 3022, 3023, 3024, 3025, 3026, 3027, 3028, 3029, 3030,

3031, 3032, 3033, 3034, 3035, 3036, 3037, 4005, 4006, 4007, 4008, 4010, 4011, 4012, 4013, 4014, 4015, 4016, 4017, 4018, 4019, 4020, 4021, 4022, 4024, 4027, 4029, and 4030 of Census Tract 52, and Blocks 3027, 4000, 4001, 4002, 4003, 4004, 4005, 4006, 4024, 4025, 4026, 4027, 4029, 4031, and 4032 of Census Tract 102.04.

(d) District Four shall be composed of Blocks 2019, 3006, 3007, 3008, 3016, 3021, 3022, 3023, 3024, 3025, 3026, 3030, 4009, 4010, 4011, 4012, 4013, 4016, 4017, 4018, 4019, 4020, 4021, 4022, and 4033 of Census Tract 102.04, Blocks 2001, 2002, 2003, 2004, 2005, and 2010 of Census Tract 52, Blocks 1001, 1002, 1004, 1006, 1007, 1008, 1009, 1010, 1011, 1012, 1013, 1018, 1019, 1020, 1021, 1022, 1023, 1024, 1025, 1026, 1027, 1028, 1029, 1030, 1031, 1032, 1033, 1034, 1035, 1036, 1037, 1041, 1042, 1043, 1044, 1045, 1046, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, and 2017 of Census Tract 51.01, and Blocks 2017, 2022, 3028, and 3059 of Census Tract 102.03.

(e) District Five shall be composed of Block 1000 of Census Tract 51.01, Blocks 3029, 3030, 3031, 3032, 3033, 3034, 3035, 3036, 3038, 3039, 3040, 3041, 3042, 3046, 3048, 3049, 3050, 3051, 3052, 3053, 3054, 3055, 3060, 3062, and 3063 of Census Tract 102.03, and Blocks 1000, 1001, 1002, 1003, 1004, 1005, 1006, 1007, 1008, 1009, 1010, 1011, 1012, 1013, 1014, 1015, 1016, 1017, 1018, 1019, 1022, 1023, 2000, 2001, 2002, 2003, 2004, 2005, 2006, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021, 2022, 2023, 2024, 2025, 2026, 2027, 2028, 2029, 2030, 2031, 2032, 2033, 3007, 3008, 3011, 3012, 3013, 3014, 3016, 3017, 3020, 3021, 3022, 3023, and 3033 of Census Tract 51.02.

Section 2. This ordinance shall be in full force and effect from and after its passage and signing by the Mayor.

Section 3. This ordinance shall not be construed as affecting the elected membership of the Common Council prior to its application in the election of 2015.
