RECITALS

PB and Owner entered into the above-referenced Professional Services Task Order Contract ("Subcontract") for the performance of services pursuant to Task Orders. The parties thereafter entered into Task Order No.3, dated July 11, 2012, for the performance of Professional Services.

PB and Owner now desire to amend Task Order 3 to add Services to be performed and fee breakdown applicable to the additional Services.

Therefore, for the consideration hereinafter set forth and other good and valuable consideration, the receipt and sufficiency of which the parties hereto by their signatures below affirm, the parties do mutually agree as follows:

TERMS


The above recitals are incorporated herein and made a part hereof as if fully set forth.

- A. Article 1, Scope of Services. Attachment 3A-1 is amended to include those Services set forth in Appendix A-1—Amendment #2, Scope of Services, appended hereto and by this reference incorporated herein for all purposes as if fully set forth.
- B. Article 3, Compensation. Article 3 is amended to include those fees set forth in Appendix A-2—Amendment #2, Compensation, appended hereto and by this reference incorporated herein for all purposes as if fully set forth. The maximum-not-to-exceed amount of the Task Order, as set forth in Section 2 thereof, is increased by **\$21,654.74**, for a revised maximum not-to-exceed Task Order amount of **ONE HUNDRED AND SIXTY THOUSAND SEVEN HUNDRED AND FIFTY EIGHT AND 74/100 DOLLARS (\$164,758.74)**.

IN WITNESS WHEREOF, the parties have executed this Amendment No. 2 to Contract Task Order No. 3, effective as of the date first written above.
