West Lafayette Redevelopment Commission

This Request for Quote is the official notice of needed construction services for the West Lafayette Board of Parks & Recreation (the "Board") by and through the West Lafayette Redevelopment Commission (the "Commission").

The Contractor shall furnish all labor, equipment, and materials necessary for the Garden Street Right-of-Way Improvements Concrete Installation, according to the attached drawing, West Lafayette Typical Construction Guidelines and Details (http://www.westlafayette.in.gov/egov/docs/1372789420_146606.pdf), and the following specifications:

1. Remove 180' of old, existing 8' wide concrete walk east of Summit.
2. Excavate to 8" below adjacent surface in area of old walk.
3. Install and compact 4" thick base of #53 stone in excavated area.
4. Install 4" thick concrete walk (6 bag concrete mix with fiber mesh), including ADA ramp at Summit, all to drain to surrounding surfaces with < 2% cross slope, with sawed joints and light broom finish.
5. Seal concrete.

The Contractor shall be responsible for the determination and notification of all affected utilities and for the coordination of all work with the utilities and the Board. The Contractor shall be responsible for construction layout on-site per the plans and for receiving approval by the Board prior to proceeding with work. Any necessary permits will be provided by the Board.

The Contractor shall carry all necessary insurance coverage and provide a certificate of insurance to the Board and to the Commission per the City of West Lafayette insurance requirements.

Quotes should be submitted on the enclosed Quote Sheet on or before 8:30 a.m. on September 9, 2014 to: Office of the Clerk-Treasurer by email (clerk@wl.in.gov), by mail (711 W. Navajo St., West Lafayette, IN 47906), or by FAX (765-807-0229). The email subject line, mailing envelope, or FAX cover sheet should indicate "Garden Street Right-of-Way Improvements Concrete Installation," and properly executed Non-Collusion Affirmation and Employment Eligibility Verification forms should be submitted with the Quote Sheet, unless the firm already has current forms on file with the Office of the Clerk-Treasurer.

Quotes will be read into the record at the regularly scheduled meeting of the Board of Public Works & Safety on September 9, 2014. Quotes will be taken under consideration for the issuance of a purchase order to the most responsive and responsible firm which provides a quote most advantageous to the Commission.
