

ORDINANCE NO. 22-05

**AN ORDINANCE TO AMEND WEST LAFAYETTE CITY CODE
CONCERNING PREAPPROVED PAYMENT OF CLAIMS**

WHEREAS, West Lafayette City Code Chapter 25.10, in accordance with Indiana Code 36-4-8-14, provides that the Common Council may adopt an ordinance allowing preapproved payment of claims; and

Whereas, the Financial Manager of the Wastewater Treatment Utility has determined that it would improve the efficiency of the collection of delinquent accounts, pursuant to City Code Sec. 30.09.16, to allow payments in advance of board allowance for lien recording fees; and

Whereas, the board having jurisdiction over the allowance of claims must provide pre-written approval for the City fiscal officer to make claim payments in advance of board allowance, and the Board of Public Works and Safety has done so in Resolution No. BW-2-2005 adopted on August 16, 2005.

Now therefore, be it ordained by the Common Council of the City of West Lafayette that West Lafayette City Code Section 25.10 be amended to read as follows:

(19) Payments for Wastewater Treatment utility lien recording fees due to the Tippecanoe County Recorder.

~~(19)~~ **(20)** Expenses that must be paid because of an emergency requirement.

~~(20)~~ **(21)** Expenses described in an ordinance.

This ordinance shall be in full force and effect after its passage and signing by the Mayor.
