

Ordinance No. 29-09

**AN ORDINANCE VACATING A CERTAIN UTILITY AND DRAINAGE EASEMENT
IN THE CITY OF WEST LAFAYETTE, INDIANA**

WHEREAS, the easement to be vacated is approximately ten (10) feet in width and its legal description is shown on Exhibit "A" attached hereto and made a part hereof;

WHEREAS, the Easement to be vacated is located between and contiguous with Lots 3 and 4 in the Replat of Lot 1 of McClure Park Subdivision, Part Two as per plat thereof recorded in Plat Book C, Slide C-59 in the Office of the Recorder of Tippecanoe County, Indiana, as shown in a drawing prepared by The Schneider Corporation, marked as Exhibit "A", attached hereto and incorporated herein;

WHEREAS, the contiguous property to said area to be vacated is the property of Fairfield Builder's Supply Co.;

WHEREAS, the petitioner for the vacation of the Easement has complied with the provisions of the Indiana Code with a public hearing being held; and

WHEREAS, the petitioner for the vacation of the Easement requests that the Easement be vacated and title to the Easement be transferred to Fairfield Builder's Supply Co.

NOW THEREFORE, BE IT ORDAINED by the Common Council of the City of West Lafayette that:

Section 1. The Easement, which is approximately ten (10) feet in width and running between and contiguous with Lots 3 and 4 in the Replat of Lot 1 of McClure Park Subdivision, City of West Lafayette, Indiana, as shown as Exhibit "A" is hereby vacated.

Section 2. The Easement as described in Exhibit "A" is hereby conveyed to the owner, Fairfield Builder's Supply Co.

Section 3: This ordinance shall be in full force and effect from and after its passage and signing by the Mayor.

PETITION TO VACATE EASEMENT

Comes now petitioner, the City of West Lafayette, an Indiana Municipal Corporation with the consent of and on behalf of the owner of certain real estate and respectfully requests that a certain easement for utility and drainage purposes in the City of West Lafayette, be vacated under the procedures set forth in Indiana Code § 36-7-3-12 and that the proper authorities schedule a public hearing on this petition, give proper notice of said public hearing at the expense of the petitioner, and duly adopt an ordinance in the format and substance submitted herewith.

The requested vacation is of an easement that is approximately ten (10) feet in width and running between and contiguous with Lots 3 and 4 in the Replat of Lot 1 of the McClure Park Subdivision, City of West Lafayette, Indiana, owned by Fairfield Builder's Supply Co., P.O. Box 4437, Lafayette, IN 47903, included in and shown in a drawing of said Lots prepared by The Schneider Corporation, a copy of which is attached hereto as Exhibit "A" and incorporated herein.

All of the above is requested for the good and benefit of the City of West Lafayette, Indiana.


LAND DESCRIPTION

A part of Lots 3 and 4 in the Replat of Lot 1 of McClure Park Subdivision, Part Two as per plat thereof recorded in Plat Book C, Slide C-59 in the Office of the Recorder of Tippecanoe County, Indiana, all in the City of West Lafayette, Indiana, being a strip of land depicted as a utility and drainage easement on said Replat, said strip of land being 10 feet wide, the centerline of said strip of land being more particularly described as follows:

That portion of the west line of said Lot 3, bounded on the south by north line of a 5 foot wide drainage and utility easement as depicted on said Replat, and on the north by the south line of a 15 foot wide drainage and utility easement as depicted on said Replat, the side lines of said strip of land being lengthened or shortened to terminate at the respective drainage and utility easement lines.
