

ORDINANCE NO. 14-11

**AN ORDINANCE TO RATIFY AND ADOPT CORRECTIONS TO
CHAPTERS 10 THROUGH 67 OF THE "WEST LAFAYETTE CITY CODE"**

Whereas, the City of West Lafayette maintains codified ordinances and resolutions in the "West Lafayette City Code", hereinafter referred to as the City Code; and,

Whereas, a number of errors have been identified in chapters 10 through 67 of the City Code, as listed in the attached "Appendix A";

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF WEST LAFAYETTE that corrections to chapters 10 through 67 of the City Code, as detailed and documented in the attached "Appendix A", shall be ratified and adopted.

Appendix A

1) Chapter 10, Sec. 10.02. Captions of sections.

Footnotes 2, 3, 4, and 5 refer to Indiana statutes that have been repealed. The footnotes shall be removed. Subsequently, footnote 6 will be renumbered as footnote "2".

2) Chapter 20, Sec. 20.07. Ordinance Violations Bureau.

Reference to "Indiana Code § 33-6-3-1" shall be changed to the correct statute, "Indiana Code § 33-36-2-1".

3) Chapter 20, Sec. 20.08. Ordinance Violations Bureau Fines.

(a) Parking Violations lists fines for parking violations that was not updated. The updated fines are in Sec 44.11. Only (1) and (7) are not updated.

(1) Ten dollars for time restricted parking as defined by chapter 44 of the West Lafayette City Code.

Shall be changed to:

(1) Fines for time restricted parking as defined by chapter 44 of the West Lafayette City Code are listed in chapter 44.11(a) Fines.

(7) Fifteen dollar fine for all other parking violations as defined by chapter 44 and 51.08(i) of the West Lafayette City Code.

Shall be changed to:

(7) Fines for all other parking violations as defined by chapter 44 and 51.08(i) of the West Lafayette City Code are listed in listed in chapter 44.11(e) Fines.

4) Chapter 21, Sec. 21.03. Time of regular meeting.

The regular monthly meeting time shall be corrected, changing "7:30 P.M." to "6:30 P.M."

5) Chapter 21, Sec. 21.06. Agenda; filing of proposed ordinance.

Paragraph (b) states:

(b) All proposed ordinances, resolutions, or petitions shall be filed with an original and fifteen copies, and shall be filed with the clerk-treasurer in writing by four p.m. at least eleven days prior to any regular council meeting. Each item shall bear the name of the person(s), committee or agency submitting the item.

As "fifteen copies" are no longer required and shall be provided electronically, the paragraph will be changed to:

(b) All proposed ordinances, resolutions, or petitions shall be filed with the clerk-treasurer in writing by four p.m. at least eleven days prior to any regular council meeting and shall also be provided in an electronic format acceptable to the Clerk-Treasurer's office. Each item shall bear the name of the person(s), committee or agency submitting the item.

6) Chapter 22, Sec. 22.60. City judge; office created; duties generally.

The reference to "Indiana Code chapter 33-10.1-2" (repealed) shall be changed to the correct statute, "Indiana Code § 33-35-2".

7) Chapter 24, Article VIII. Parks.2 (index)

The reference to "[Indiana Code] § 46.13" shall be changed to "§ 46.11" in footnote 2.

8) Chapter 24, Sec. 24.02. Definitions.

Within the definition of *Real estate broker*, the reference to "Indiana Code § 25-34.1-1-2(2)" shall be changed to "Indiana Code § 25-34.1-2(4), (5)".

9) Chapter 24, Sec. 24.20. Participation in operation of area plan commission.

The reference to "Indiana Code 1971, § 18-7-4-1 et seq.," (repealed) shall be changed to Indiana Code § 36-7-4."

10) Chapter 24, Sec. 24.21. Adoption of state law.

The reference to "Indiana Code, 1971, §§ 18-7-4-1 to 18-7-4-99" (repealed) shall be changed to "Indiana Code § 36-7-4".

11) Chapter 25, Sec. 25.01. Cumulative capital improvement fund.

The reference to "Indiana Code § 6-7-1-31-1" (repealed) shall be changed to "Indiana Code § 6-7-1-30.1".

12) Chapter 30, Sec. 30.09.4. Procedure when water is obtained partially or wholly from sources other than the West Lafayette Water Company

The references to "West Lafayette Water Company" within the section and the section title shall be changed to "Indiana American Water Company".

13) Chapter 40, Sec. 40.17. Same--Restrictions on direction of movement during certain periods.

Misspelled word "raffic" shall be changed to "traffic".

14) Chapter 42, Traffic Control Devices; Speed Regulations; Turning Movements.1 (index)

Within footnote 1, the misspelled word "traffi-control" shall be changed to "traffic-control".

15) Chapter 44, Sec. 44.11. Fines.

Paragraph (b) references "section 44.09 (unauthorized parking on private property)". The section reference shall be changed to "section 44.08".

16) Chapter 50, Sec. 50.02. Exemptions.

Paragraph (a) references "Indiana Code §§ 9-24-1-2 and 9-24-1-3". As I.C. 9-24-1-3 has been repealed, the reference will be changed to "Indiana Code § 9-24-1-2".

17) Chapter 51, Sec. 51.02. Permit Program Establishment.

In the text "... vehicles bearing a valid parking permit issued a pursuant to this Code ...", the "a" shall be deleted, resulting in "... vehicles bearing a valid parking permit issued pursuant to this Code ...".

18) Chapter 51, Sec. 51.08. Violation and Enforcement.

In Paragraph (d), the reference to "... the one, two or three hour parking restrictions of the Neighborhood Parking Permit area ..." shall be changed to "... the one or two hour parking restrictions of the Neighborhood Parking Permit area ...".

19) Chapter 60, Sec. 60.02. Requirement of information sheets posted on or adjacent to alarm panels.

The section heading shall be changed to match the index, changing "Requirement of information ..." to "Monitoring fee".

20) Chapter 61, Sec. 61.04. Dog licenses.2

Within footnote 2, the reference to " Indiana Code chapters 15-5-9 to 15-5-12" (repealed) shall be changed to "Indiana Code §§ 15-20-1 to 15-21-7".

21) Chapter 62, Sec. 62.03. Powers of mayor.

In paragraph (d) (4), the errant "t" within the text "... designated by t the mayor ..." shall be removed. The misspelled last word of the paragraph, "ttherein", will be corrected to "therein".

22) Chapter 63, Fire Protection.1 (index)

The reference to "§ 66.07" within footnote 1 shall be changed to "§ 24.136".

23) Chapter 63, Sec. 63.11. Administration review and appeals.

Within paragraphs (a) and (b), the references to "§ 63.49" shall be changed to "§ 63.10".

24) Chapter 63, Sec. 63.41. Fireworks--Public displays.

The reference to "§ 63.20" within the first paragraph shall be changed to "§ 63.40".

25) Chapter 64, Sec. 64.9. Public Education.

The section heading "64.9" will be changed to "64.09".

26) Chapter 66, Streets and Sidewalks.1 (index)

The original text of footnote 1:

The reference to "... the West Lafayette Water Company" shall be changed to "... the Indiana American Water Company".
